## **Del Monte Foods' Knetsch Elected Chair of Food Products Board**

James Knetsch, Vice President of Operations for Del Monte Foods, Inc., based in Rochelle, IL, has been named chairman of Midwest Food Products Association's (MWFPA) board of directors for 2019.
