2. Grade point average (transcript required)
3. Letter of recommendation from advisor or other faculty member
4. Letter of interest from the student (not to exceed 4 pages)
5. Letter of recommendation from past or present employer(s)
6. Indication of need for financial assistance (listed on the application form)
7. Summer and/or permanent address and phone number

Incomplete applications and applications received/post marked after the deadline stated on the applications will not be considered.
